
Mandatory Registration of Identification Data in the Commercial Register

Dear Client,

In connection with the amendment of the applicable legislation (Act on the Commercial Register, Commercial Code), we draw your attention to the obligation to add data to the relevant Commercial Register of the Slovak Republic. The entry of the data must be made by 30 September 2022 at the latest.

You can quickly check whether this obligation applies to you on the Commercial Register of the Slovak Republic website at www.orsr.sk.

If the info icons are green, no further registration is necessary.



If the info icons are red, it is <u>necessary to make an entry in the Commercial Register</u> (add identification data).

Data to be completed:

• **INDIVIDUAL** - shareholder, statutory body, head of the organizational unit, proxy, member of the supervisory board, liquidator = date of birth, birth number assigned in Slovakia. If not assigned, then **other identification data**: EU ID card number or passport number.

In the case of the establishment of a pledge on a shareholder's business share, the following must be added: the information on its establishment, the name, surname, date of birth of the natural person or the business name, registered office and identification number, if assigned, of the legal entity that is entered in the commercial register as the pledgee of the business share, and the designation of the pledge agreement.

• **LEGAL PERSON** - shareholder, statutory body = ID number assigned in Slovakia. If not assigned, then <u>other identification data</u>: company identification number, number of registration in the Commercial Register, etc.

What is required:

- a signed **Power of Attorney** a handwritten signature and a scanned copy is sufficient
- a Declaration of Honor with the specified identifiers of the natural or legal person, accompanied by a notarized signature (if applicable)
