## News in our office

Especially in the area of cross-border employee assignment the regulations are harassing, various EU proceedings are pending, e.g. against the regulation on minimum wages for truck drivers.

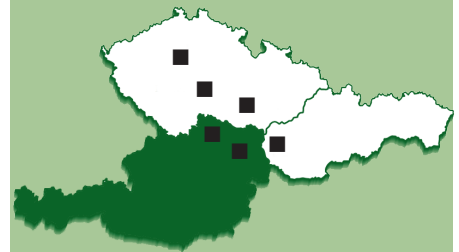
